Head of Cabinet of the Minister of Agriculture, participating in the MacSharry reform of the Common Agricultural Policy (1991-1993).

Advisor on international economic relations in the Cabinet of the President's Office of the Government of Spain, participating in the negotiations of the Maastricht Treaty (1986-1991).

Territorial Deputy-Director in Valencia, participating in the Management Committee for the export of citrus fruits and in the Executive Board of the Chamber of Commerce (1983-1986).

He has been a tenured professor at the 'Escuela de Organización Industrial' (EOI) and at the 'Instituto de Empresa' (IE) where he was an associate professor of Economic Environment in an Executive Master.

Author of several books on economic and political matters.
